Saint Louise Hospital Ambulance Diversion Trial Program	<p><u>Josh Davies, EMS Agency:</u> Reported Saint Louise Hospital's emergency department was beginning a trial ambulance diversion program. The diversion program has been authorized for a 90-day trial period and will begin on May 22nd. The program will be evaluated weekly to ensure that there are no significant impacts to the EMS System.</p>

Auto-Pulse Utilization by County Fire	<u>Josh Davies, EMS Agency:</u> Reported Santa Clara County Fire Department has completed training on the Auto-Pulse Chest Compression Device. Their department has deployed the device on their department's first response apparatus.
Public Access Defibrillation Program / Process	<u>Josh Davies, EMS Agency:</u> Provided an update on upcoming AED requirements legislated by the State for Gym and Fitness Centers as well as the Agency's revised AED registration program. He reported that the Agency recently held two informational symposiums for business affected by the new requirements. The new requirements become effective on July 1, 2007.
Annual EMS Asset Self-Inspections	<u>John Blain, EMS Agency:</u> Reported the annual EMS Asset Self-Inspection program begun on May 1 st . All provider agencies will need to complete the process by May 31 st .
EMS Week	<u>John Blain, EMS Agency:</u> Announced that the EMS Agency will be holding a ceremony and BBQ on May 24 th to celebrate EMS Week. All EMS System providers are invited and encouraged to attend.
EMS Update / Train-the-Trainer Course	<u>Josh Davies, EMS Agency:</u> Announced September 25 th as the date for this year's EMS Update "Train-the-Trainer Course".
Fitch & Associates EMS System Review	<u>Josh Davies, EMS Agency:</u> Reported that Fitch & Associates had been hired to conduct an annual EMS System review. Committee members were informed that Fitch & Associates would be contacting stakeholders to solicit feedback on the status of the County's EMS System.
EMS Trust Fund	<u>Josh Davies, EMS Agency:</u> Announced that funding applications may be submitted to the Agency for EMS related projects. All applications must meet established funding standards and provide a benefit to the entire EMS System.

Review of Recent Exercises	<u>Michael Clark, EMS Agency:</u> Provided an overview report on past exercises and drills conducted by EMS and Public Health Department.
Prehospital Accreditation / Certification	
Certification & Identification Process Update	<u>Patricia Natividad, EMS Agency:</u> Provided an update on changes to EMS personnel application processing. Personnel seeking EMT Certification and ID cards will now be required to show the Agency two forms of valid government issued identification. The Agency is exploring the use of FBI criminal background checks in addition to the State's DOJ criminal background checks.
Paramedic Accreditation Test Redevelopment	<u>Patricia Natividad, EMS Agency:</u> Announced that the Agency will be revising the paramedic accreditation written test. Requesting stakeholder involvement to include the submission of potential test questions.
Prehospital Identification Policy Development	<u>John Blain, EMS Agency:</u> Announced that the Agency is exploring the development of a stand-alone prehospital identification policy. Currently, prehospital identification standards are identified in EMS Policy 613, which includes protective gear standards.
Policy 214 – Prehospital Training Standards Update	<u>John Blain, EMS Agency:</u> Reported that the federal government had issued a new training requirement for EMS managerial and supervisory personnel. The new mandate now requires that all managers and supervisors complete the Department of Homeland Security's National Response Plan Course (IS-800). The self-study course is available through FEMA's website. The changes will require modification to Prehospital Care Policy 214 and those changes will occur in January 2009.

Countywide Medical Response System (CMRS)	
California Health Alert Network (CAHAN) Utilization	<u>Josh Davies, EMS Agency:</u> Advised committee members that the Agency will be utilizing the California Health Alert Network (CAHAN) as a method to provide EMS System management personnel with critical notifications through existing communication devices (phone, pager, email). The system is web-based and is operated by the California Department of Health Services.
Pandemic Flu Plan Update	<u>Josh Davies, EMS Agency:</u> Reported that the Public Health Department was nearing completion of the County's Pandemic Flu Plan. Included in the plan are guidelines for the establishment of Influenza Care Centers (ICCs). These ICCs will be deployed throughout the County when needed. The County has begun the process of purchasing equipment and supplies to support the ICCs.
Pandemic Flu Guide Distribution by EMS Providers	<u>Josh Davies, EMS Agency:</u> Announced that the Public Health Department had received funding to produce 80,000 more Pandemic Flu Guides. The guides will be printed in English, Spanish and Vietnamese and will be provided to all of the County's EMS providers for public distribution. Providers will distribute these guides on 9-1-1 events, when appropriate or during other interactions with the public.
