| July 13, 2009 (E – 113) | <p><u>NOMINATION PERIOD OPENS</u></p> <p>First day candidates may pick up nomination documents either at the district office or at the Office of the Registrar of Voters.</p> |
| August 7, 2009 (E – 88) | <p><u>NOMINATION PERIOD CLOSES *</u></p> <p>Deadline to file (in the Office of the Registrar of Voters only) all required nomination documents.</p> <p><u>WITHDRAWAL OF CANDIDATE</u></p> <p>No candidate shall withdraw after 5:00 p.m. on this date for offices which do not have an extension period.</p> <p><u>DUE DATE FOR MEASURE RESOLUTIONS AND TAX RATE STATEMENTS *</u></p> <p>Last day for jurisdictions to file a resolution calling for a measure election, and if applicable, tax rate statements.</p> |
| August 8 through August 12, 2009 (E – 87 to E – 83) | <p><u>EXTENSION PERIOD *</u></p> <p>If an incumbent fails to file a Declaration of Candidacy by August 7th for his or her office, there will be a 5-calendar-day extension during which any candidate, other than the incumbent, may file or withdraw from said office.</p> |
| August 12, 2009 (E – 83) | <p><u>DUE DATE FOR ARGUMENTS *</u></p> <p>Deadline set by the Registrar of Voters for submitting arguments in favor of and against a measure.</p> |
| August 13, 2009 (E – 82) | <p><u>RANDOMIZED ALPHABET DRAWING</u></p> <p>This day the Secretary of State and the local elections official will conduct a drawing of letters of the alphabet to determine the order in which candidates appear on the ballot.</p> |
| August 19, 2009 (E – 76) | <p><u>DUE DATE FOR REBUTTALS AND IMPARTIAL ANALYSES *</u></p> <p>Deadline set by the Registrar of Voters for submitting rebuttals to arguments in favor of and against and the impartial analysis.</p> |
| September 8 through October 20, 2009 (E – 57 to E – 14) | <p><u>WRITE-IN CANDIDACY OPENS AND CLOSES</u></p> <p>Time frame for write-in candidates to obtain and file nomination documents in the Office of the Registrar of Voters.</p> |

| October 5, 2009 (E – 29) | <u>FIRST DAY FOR MAILING OF VOTE BY MAIL BALLOTS</u> First day of mailing of Vote By Mail ballots. |
| October 19, 2009 (E – 15) | <u>LAST DAY TO REGISTER TO VOTE FOR NOVEMBER ELECTION</u> Deadline to register to vote to be eligible to vote in the November 3, 2009 election. |
| October 22, 2009 (E – 12) | <u>F.P.P.C. 2nd PRE-ELECTION STATEMENT DUE</u> Deadline for financial disclosure report Form 460 covering the period of 9-20-09 to 10-17-09. |
| October 18 through November 2, 2009 (E – 16 to E – 1) | <u>LATE CONTRIBUTION/INDEPENDENT EXPENDITURES</u> Sums over \$1000 to/from a single source must be reported within 24 hours. The Late Independent Expenditure report is required only for committees (not candidate committees) that make independent expenditures totaling \$1,000 or more to support or oppose a single candidate or a single ballot measure. |
| October 27, 2009 (E – 7) | <u>LAST DAY TO REQUEST VOTE BY MAIL BALLOT BY MAIL</u> Deadline at 5:00 p.m. to submit a request for a Vote By Mail ballot to be mailed to voter. |
| NOVEMBER 3, 2009 | <u>ELECTION DAY</u> Polls are open from 7:00 a.m. to 8:00 p.m. |
| November 23, 2009 | <u>OFFICIAL CANVASS OF VOTE</u> Deadline for Registrar of Voters to certify election results. |

This calendar may not contain all of a candidate's or district's filing requirements. The Office of the Registrar of Voters is not open for filings on Saturday, Sunday or holidays.

* The legal 10-calendar-day public examination period in which a writ of mandate may be sought begins immediately following the filing deadline for submission of those documents. The writ of mandate request shall be filed no later than the end of the 10-calendar-day public examination period.

** The period covered by any statement begins on the day after the closing date of the last statement filed, OR January 1st, if no previous statement has been filed.
