

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA CLARA APPROVING THE CHILD ABUSE PREVENTION, INTERVENTION, AND TREATMENT (CAPIT), COMMUNITY BASED CHILD ABUSE PREVENTION PROGRAM (CBCAP), AND PROMOTING SAFE AND STABLE FAMILIES (PSSF) THREE-YEAR PLAN EXTENSION

WHEREAS, the County has had a long-standing commitment to provide essential human services; and

WHEREAS, the Social Services Agency works closely with many community-based organizations, city agencies, other County agencies, and individuals to provide an array of services to the Agency's clients and community members; and

WHEREAS, the Social Services Agency has collaborated with a designated local planning body to prepare a Three-Year Plan for SFY 2005-2008 in order to receive funding for the Child Abuse Prevention, Intervention, and Treatment Program (CAPIT), Community Based Child Abuse Prevention Program (CBCAP), and Promoting Safe and Stable Families (PSSF) Programs; and

WHEREAS, the Santa Clara County Board of Supervisors approved the Three-Year Plan for SFY 2005-2008 on August 23, 2005 through the adoption of a resolution; and

WHEREAS, effective July 1, 2009 the California Department of Social Services is requiring the integration of the CAPIT/CBCAP/PSSF Three-Year Plan and the Self Assessment/System Outcome Improvement Plans; and

WHEREAS, the California Department of Social Services is allowing counties to extend the timeframe of their existing CAPIT/CBCAP/PSSF approved Three-Year Plan, and as appropriate, vendor contracts, until the Social Services Agency's County Self Assessment /System Outcome Improvement Plans are due; and

WHEREAS, the Social Services Agency's next County Self Assessment/System Outcome Improvement Plans due after July 1, 2009 is June 6, 2012; and

WHEREAS, the Social Services Agency is required by the California Department of Social Services to provide documentation that the Santa Clara County Board of Supervisors has approved the extension of the CAPIT/CBCAP/PSSF Three-Year Plan until June 6, 2012; and

THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Santa Clara hereby approves the extension of the CAPIT/CBCAP/PSSF Three-

Year Plan from June 30, 2008 to June 6, 2012 and the submission of the extension to the California Department of Social Services.
