

**First Amendment to the Agreement
Between The County Of Santa Clara and Stericycle Inc.
For Medical Waste Services**

This is the First Amendment to the Agreement between the County of Santa Clara (County) and Stericycle Inc. (Stericycle) effective July 1, 2006, to provide services related to the pickup, transportation and disposal of medical waste (Agreement):


The parties agree to modify the Agreement as follows effective July 1, 2009:

1. Section C of the Agreement "Term of the Agreement" shall be extended two years to expire on June 30, 2011.
2. Section D subsection 4 of the Agreement is replaced with the following: "Compensation paid under this Agreement shall not exceed Four Hundred Thousand Dollars (\$400,000.00) for each year of the Agreement, for a total of \$1,200,000 for the initial three year period, and \$800,000.00 for the additional period July 1, 2009 through June 30, 2011."
3. Attachment 1, is replaced with Attachment 1-A attached hereto and incorporated herein by this reference.
4. Except as amended herein, all the terms and conditions of the Agreement shall remain in full force and effect. In this event of a conflict between the Agreement and this Amendment, this Amendment shall control.
