

1 **2.2 Extensions.** This Agreement is extended beyond the Initial Term for one three-year
2 period, which extension period shall commence on August 1, 2010 and expire on July 31, 2013
3 and be referred to in Exhibit L-II as "Extension Term".

4 2. All references to "Exhibit G" or "Exhibit G-I" in the existing INFORMATION
5 TECHNOLOGY Agreement No. 0530-95 as modified by Amendment I are hereby changed to read
6 "Exhibit G-II," as appropriate.

7 3. All references to "Exhibit L" or "Exhibit L-I" in the existing INFORMATION
8 TECHNOLOGY Agreement No. 0530-95 as modified by Amendment I are hereby changed to read
9 "Exhibit L-II," as appropriate.

10 4. Exhibit G-II and Exhibit L-II are attached hereto and hereby incorporated by reference
11 into and made a part of the existing INFORMATION TECHNOLOGY Agreement No. 0530-95, as
12 amended.

13 5. The parties agree that separate copies of this Amendment II to the existing
14 INFORMATION TECHNOLOGY Agreement No. 0530-95 may be signed by each of the parties and
15 this Agreement will have the same force and effect as if the original had been signed by all the parties.

16 6. Except as otherwise provided in this Amendment II, all other provisions of
17 INFORMATION TECHNOLOGY Agreement No. 0530-95 as amended by Amendment I remain
18 unchanged and in full force and effect. This Amendment II shall become effective upon execution.
