Special Events Insurance Requirements

The sponsor must carry a group policy of \$1,000,000 per occurrence with the County of Santa Clara named as additional insured.

Sponsors of food and beverage booths must carry policies of \$1,000,000 per occurrence (to cover tainted food) with the County of Santa Clara named as additional insured.

Game booth sponsor must carry at least \$300,000 per occurrence with the County of Santa Clara named as additional insured.

Aircraft owners participating in static aircraft display must be able to provide evidence of insurance.

The sponsoring agency must execute a hold-harmless agreement with the County.

Indemnification

To the extent not covered by insurance carried in favor of County, the sponsoring agency (the Sponsor) shall keep and hold harmless County from and against all claims, demands, suits, judgments, costs and expenses asserted by any person or persons, including agents or employees of County or Sponsor, by reason of death or injury to person or loss of damage to property resulting from sponsor's operations, or anything done or omitted by Sponsor, under this Indemnification except to the extent that such claims, demands, suits, judgments, costs and expenses may be attributed to acts of negligence or willful misconduct of County or its agents or employees.

County shall not be liable to Sponsor for any damages arising from any act or omission of any tenant or lessee of _____ Airport.

County shall not be liable for damage to person(s) or property arising from fire, steam, electricity, gas, water, rain, breakage, leakage, obstruction or other defects of pipes, sprinklers, wires, appliances, plumbing, air conditioning or lighting fixtures, crime or any cause whatsoever, whether such injury or damage results from conditions arising upon the Premises or by Sponsor's activities upon portion of _____ Airport.
