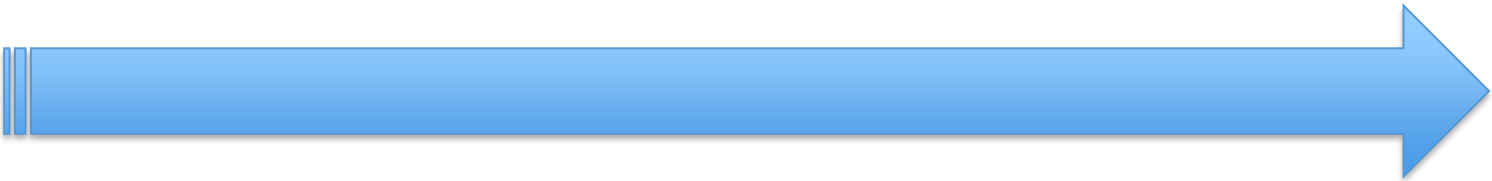

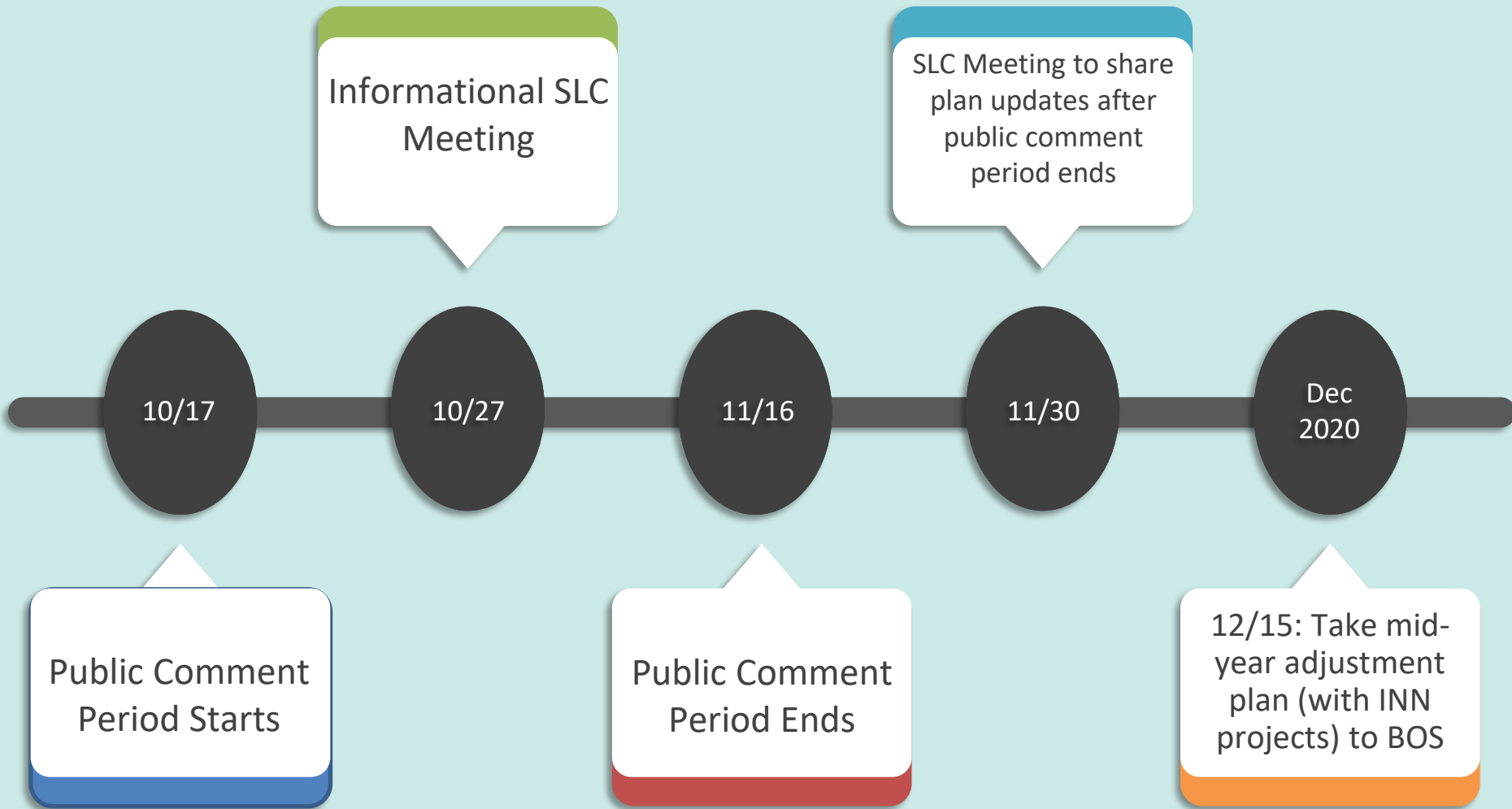

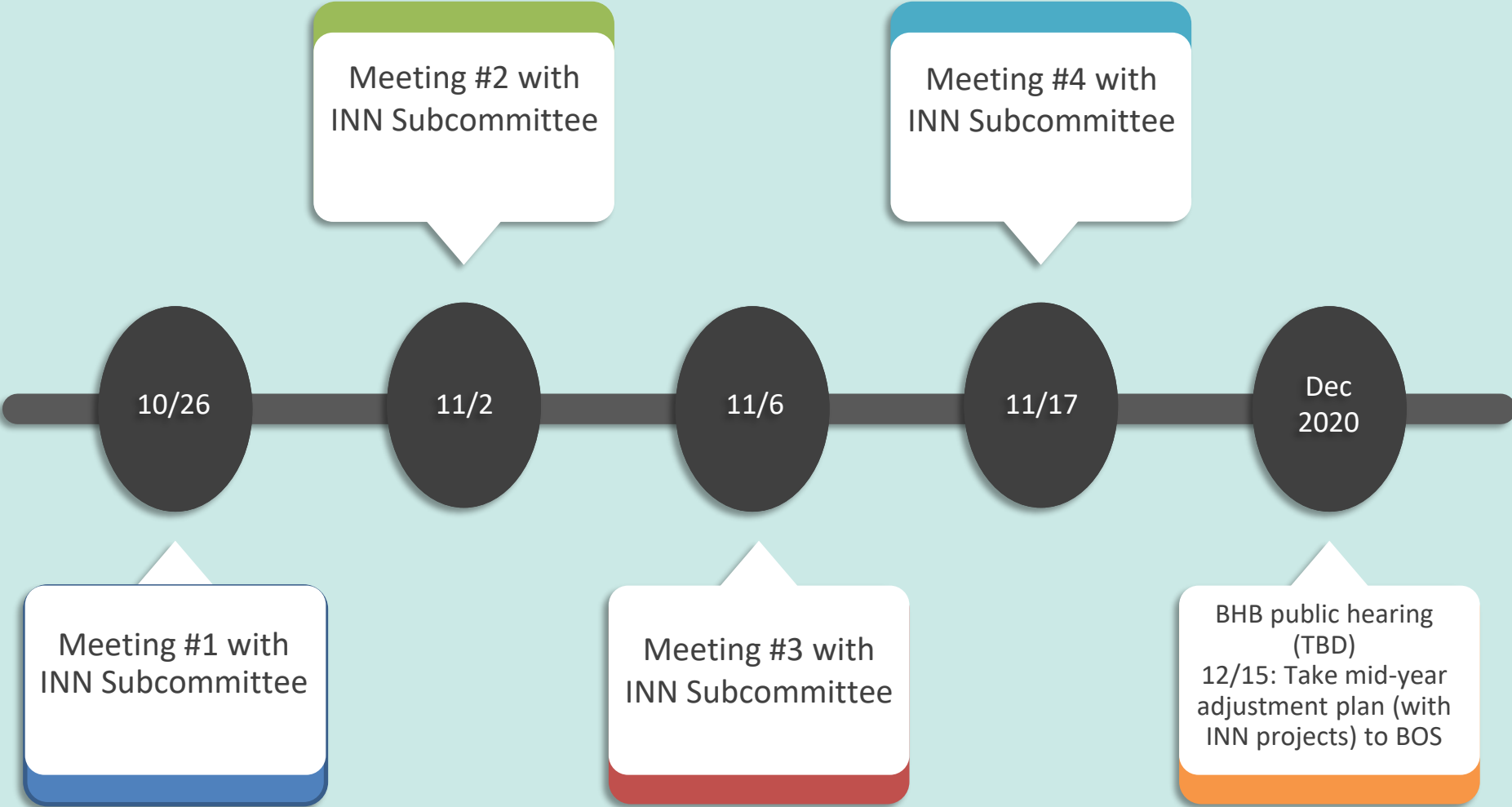

# FY 2021 MHSA New Innovations Projects Timeline

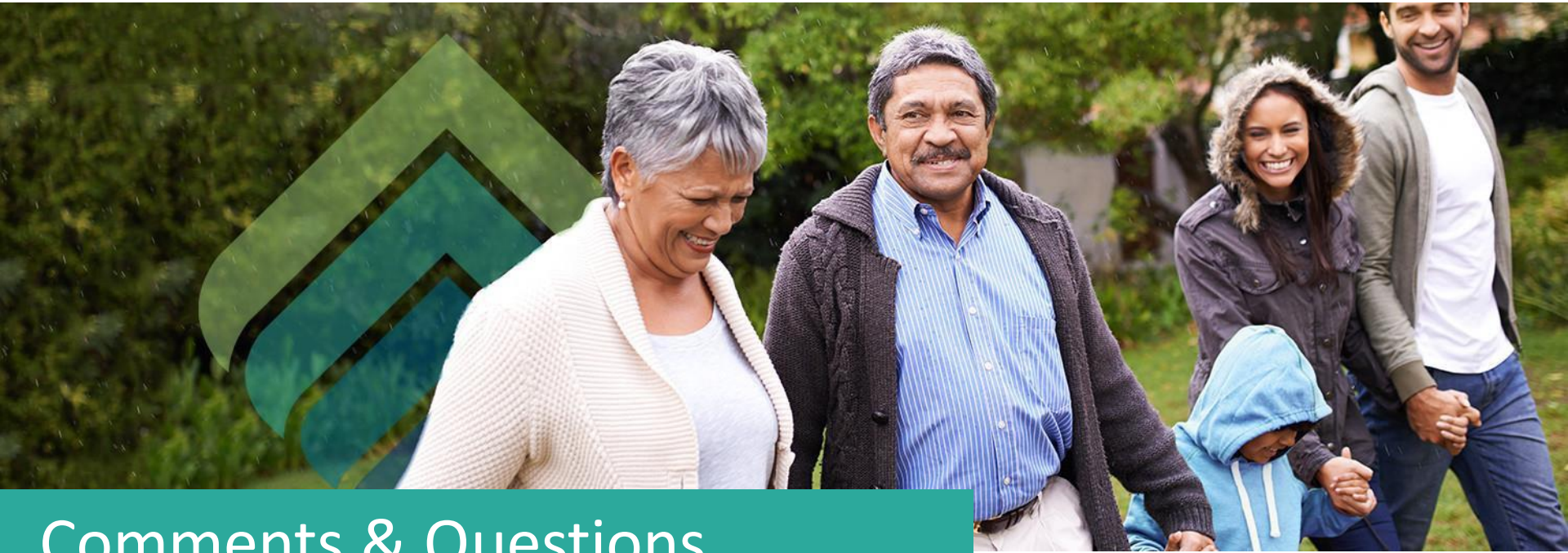
