Update on New Health Order

Dear Friends,

The new health order that County Health Officer Dr. Sara Cody announced on July 2, which will allow new businesses such as hair salons and gyms to reopen, requires approval from the State before becoming effective. The County hopes for that to happen soon.

Over the weekend, the State denied the County's approval of a variance, which is what counties need to have to allow new activities to resume under the state's stay-at-home order. But the County will keep working with the state and reapply for the variance, so stay tuned.

The new order, which we hope will still go into effect on July 13, was focused on a risk reduction strategy with precautionary measures required for businesses, including density restrictions, face covering and physical distancing requirements, and indoor and outdoor gathering limits.

The County is among 19 that are on a State monitoring list, which means the state public health department is looking at our data to help the County plan the next steps.

County Coronavirus Dashboards Update

As of Sunday, there were 5,273 confirmed cases of COVID-19 in the County and 161 deaths. There are currently 85 people hospitalized in the County who are confirmed to have COVID-19. So far, 219,619 people in Santa Clara County have been tested, with a 2.6% positive rate. The [dashboards](#) are updated daily.

Statewide, there were 260,155 cases, and 6,331 deaths; 4.6 million have been tested, with an average 6.3% positive rate over the past 14 days. For more statewide data, click [here](#).

In the U.S., there are 3 million cases, with 132,684 deaths.

Globally, 11.3 million cases and 531,806 deaths.
