Dear Friends,

So far, the 11 hospitals in Santa Clara County have enough personal protective equipment, which we now call PPEs, for the number of COVID-19 patients we have along the health workers who take care of them. But the County is expecting a surge of cases as the coronavirus continues to spread and, at some point, reach a peak.

Today, Dr. Sara Cody, the County's Public Health Officer, issued an order for a local inventory of supplies of PPEs and ventilators so we can have a better idea of what is available locally from businesses and individuals in case we can't receive them from state or federal government resources.

Simply visit the Public Health Department website and fill out the survey form by April 15 if you have large quantities of supplies. Specifically:

- Nitrile or vinyl gloves (if more than 5,000 items)
- N95 masks (if more than 500 items)
- Surgical or procedure masks (if more than 500 items)
- Safety goggles (if more than 100 items)
- Face shields (if more than 100 items)
- Gallon or larger hand sanitizers that are recognized by the Centers for Disease Control as effective in combatting COVID-19 (if more than 10 containers)
- All ventilators (regardless of condition)

It is unlikely that many individuals will have large supplies of these items, but some businesses might. In any event, please fill out the form. The information is just for the County and will not be shared. Click [here](#) for all the details and the survey form. The information is available in five languages.

### Update on Coronavirus Cases and Reminder of Dashboards

The Public Health Department's Coronavirus website dashboards show that there are 1,380 confirmed cases of COVID-19 in Santa Clara County and 46 deaths, including 95 new cases. There are 277 COVID-19 patients hospitalized and 11,782 Santa Clara County residents have been tested. About 11% are testing positive.
