[CA] Each food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. The facility must complete the following items prior to re-inspection:*

- Clean food debris behind and on cold prep units
- Contact licensed pest control to eliminate cockroaches from facility
- Seal all cracks and crevices between walls, floors, and ceilings in food prep area

- Per PIC, plumber came out and recommended they talk to landlord to figure out where the pipe lines are connected and dispose to.
