Overall Comments:

This was a follow-up inspection to the 04/22/2019 routine inspection. Observed two dead adult cockroaches on the floor in the cooking area. No other evidence of vermin were observed in the facility. All food was observed to be unadulterated and in good condition. Facility was re-opened.

Observed report for pest control service on 4/22/2019 at 6:15pm. Recommend having pest control twice per week for the next month, then twice per month for the month after. Please consult with your pest control company.

Note: no food temperature violations were observed during this follow up inspection. Placard changed from red to green. Discussed handouts: plastic straw restriction and children's meals.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
