## Record of Survey Check List

The purpose of this check list is to strive for the standardization of data shown on record of survey maps and to expedite review by the County Surveyor. Prior to submittal, please review your map for compliance with the applicable items on this check list. See map submittal requirements on the back side of this check list.

### MAP SUBMITTAL REQUIREMENTS

Please submit the following items at the time of submittal to the County Surveyors Office:

1. \_\_\_\_\_ Three prints of your record of survey map being submitted.
2. \_\_\_\_\_ Copy of current deed for the property surveyed.
3. \_\_\_\_\_ Copies of all adjoining deeds, and senior conveyances/deeds called for in the surveyed property's deed.
4. \_\_\_\_\_ Copies of unrecorded documents or maps when they are used in the map preparation, such as State R/W Maps, Herrmann Maps, McMillan Maps, Viewers Maps, etc.
5. \_\_\_\_\_ Copies of all reference/adjoiner maps or any other document used to prepare your map.
6. \_\_\_\_\_ Complete copy of electronic closure calculations used to prepare this map.
7. \_\_\_\_\_ Copy of the latest assessors map for the property being surveyed.
8. \_\_\_\_\_ Completed and signed copy of this check list.
9. \_\_\_\_\_ The fee for examination of a record of survey is \$600.00 (per County Ordinance Section C12-161.). Additional map checking fee may be required if cost exceeds the fee. All submitted reference documents will be returned to you if so requested.
10. \_\_\_\_\_ 20 day examination agreement, signed and dated on the day of initial submittal.(memo)
11. \_\_\_\_\_ To obtain the County Recorder's Map Book & Page after filing, include a postage-paid, self addressed envelope or postcard. After filing, the County Recorder will mail it to you.

A County Recorder's filing fee of \$8.00 for the first sheet, plus \$2.00 for each additional sheet will be required at the time of final submittal. There will be an additional charge of \$75.00 as mandated by the State of California per Govt. Code § 27388.1. If you want a conformed copy please provide a bond or mylar copy and an additional \$5.00 fee. Please submit a separate check made payable to the County Recorder for the appropriate amount.
