Subject: 2010 Annual EMS System Report

The Santa Clara County EMS Agency is pleased to release the 2010 Annual Emergency Medical Services System Report.

The following bullets represent notable changes in the EMS Systems statistics for Calendar Year 2009 compared to Calendar Year 2010.

- 911 EMS System call volume increased by 1186 responses.
- 911 EMS ambulance transports from the field to hospitals decreased by 4,887.
- 911 EMS aircraft responses decreased by 8.
- 911 EMS aircraft transports decreased by 8.
- Saint Louise Hospital designated a Stroke Center.
- Three additional private ambulance providers began service in the County.

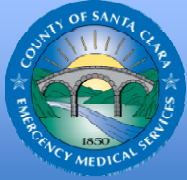
