**Community Development Block Grant (CDBG) and
Home Investment Partnership (HOME) Programs**

The County of Santa Clara, Office of Supportive Housing, HCD Division has completed the Fiscal Year 18/19 (FY18/19) Draft Annual Action Plan (Action Plan) which covers the period of July 1, 2018 through June 30, 2019. The FY18/19 Draft Annual Action Plan is the fourth of five, one-year increments to the 2015-2020 Five-Year Consolidated Plan which was adopted by the Board of Supervisors on May 5, 2015.

The Draft Action Plan establishes goals and strategies for the use of housing resources including federal, state, local and private resources for the provision of housing assistance to extremely low, low and very low income persons including the homeless as well as establishing other community development needs such as Capital Projects, Public Services, and Fair Housing services.

Preparation and adoption of the Action Plan each year is required by the U.S. Department of Housing and Urban Development (HUD) in order for the County to apply for and administer federal housing assistance funds for the Community Development Block Grant (CDBG) and HOME Programs. The participating Urban County CDBG communities include Campbell, Los Altos, Los Altos Hills, Los Gatos, Monte Sereno, Morgan Hill, Saratoga, and the Unincorporated Areas of Santa Clara County. The Urban County HOME Consortia includes the Cities of Cupertino, Gilroy, and Palo Alto.

PUBLIC REVIEW PERIOD: The FY18/19 Draft Action Plan will be available for public review for a 30-day period, beginning on May 7, 2018, concluding at the public hearing that will be held on Tuesday, June 5, 2018. Written comments may be submitted during the 30-day review period and should be sent to the Office of Supportive Housing, 3180 Newberry Drive, #150, San Jose, CA 95118 or emailed to Tracy.Cunningham@hhs.sccgov.org. These comments will be included in the FY18/19 Draft Action Plan for the final submission to HUD.

PUBLIC HEARING: The FY18/19 Draft Action Plan will be submitted to the Board of Supervisors for their approval at a Public Hearing scheduled for June 5, 2018. This meeting will be held in the Board of Supervisors Chambers located at the County Government Center, 70 West Hedding Street, San Jose, CA, 95110.
