

BayREN Home+ Rebates

Get Cash Rebates from the Bay Area Regional Energy Network (BayREN)!

The BayREN Single Family Residential Program offers you an opportunity to upgrade to an energy-efficient home that is more comfortable, durable, and safe. You'll reduce energy use and improve comfort and indoor air quality while adding value to your home – all at your own pace and budget.

Rebates are available for eligible energy efficiency upgrades including air sealing, duct sealing, insulation, high-efficiency furnaces and air conditioners, high efficiency water heaters, and more. Rebates are awarded on a first come first serve basis and available for qualifying Bay Area residents with homes built in 2001 or earlier. Customers must complete eligible improvements with a BayREN Participating Contractor in order to receive a rebate. Rebates are capped at \$5,000 per eligible customer¹. Individual measure rebates may not exceed the measure cost.

This form is intended to provide an overview of the BayREN measures and rebate amounts that will be made available starting January 1st 2019. Eligible Program Measures & Rebate Amounts

Measure	2019 Rebate Amount
<i>Operations and Maintenance Measures</i>	
Smart Thermostat (must be listed on the ENERGY STAR qualified product list for Smart Communicating Thermostat)	\$150
Duct sealing ≤ 5% total leakage	\$400
<i>Building Shell Measures</i>	
Attic insulation ≥ R-44 (includes attic air sealing)	\$0.75 / ft ² (not to exceed \$1,000 per home)
Wall insulation ≥ R-13 (2x4 framing) or ≥ R-19 (2x6 framing)	\$2.00 / ft ² (not to exceed \$1,000 per home)

¹ Customer must not have previously received a rebate for the same product or equipment from more than one energy-efficiency program offering rebates, financing or other rebates funded with PG&E ratepayer dollars within the past three years for O&M measures and eight years for building shell and HVAC measures. Customers may not exceed the \$5,000 cap over an eight-year period.



BayREN Home+ Rebates

Heating and Cooling Measures

High efficiency central gas furnace \geq 95% AFUE (must replace existing central gas furnace)	\$850
High efficiency central air conditioner \geq 17 SEER (must replace existing central air conditioner)	\$500
High efficiency heat pump \geq 17 SEER / 9.4 HSPF (must replace entire load associated with existing central air conditioner or electric heating system or heat pump)	\$1,000

Water Heating Measures

High efficiency gas water heater \geq 0.70 EF (must replace existing gas water heater)	\$400
Heat pump water heater \geq 3.24 EF (must replace existing electric or heat pump water heater)	\$1,500

Bonus Rebates

Combine one or more Building Shell measures with a Heating or Cooling measure	\$500
Downsize heating and/or cooling system compared to existing system	\$100
Building air sealing \geq 30% total leakage reduction	\$150
Combustion Appliance Safety (CAS) test-out	\$150
