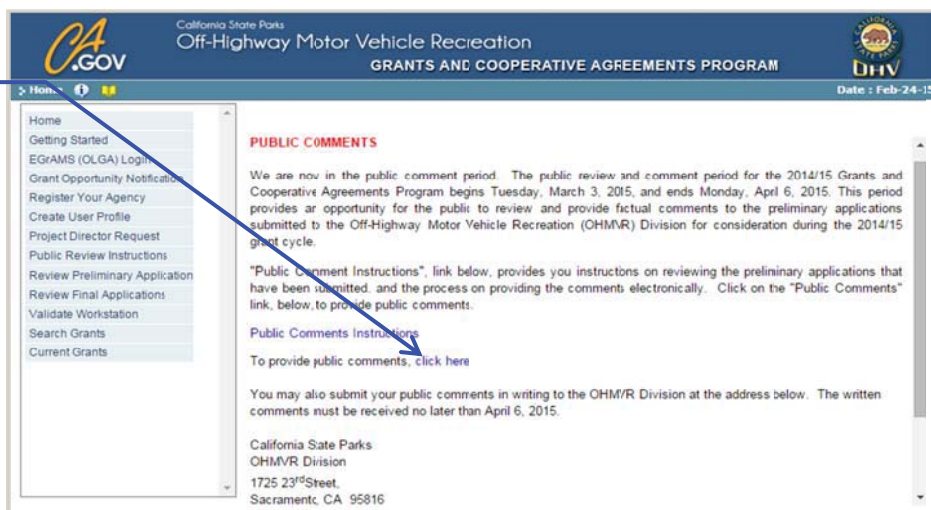


## PUBLIC REVIEW AND COMMENT INSTRUCTIONS

Welcome to the Grants and Cooperative Agreements Program Public Review and Comment Period. The following steps will direct you in viewing any and all preliminary applications, and also instruct you on how to submit comments to the Applicants through the Online Grant Application (OLGA) database.

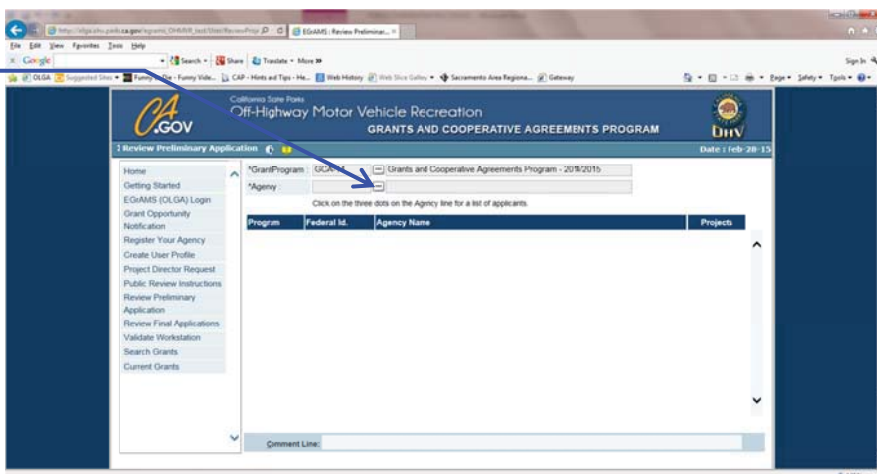
**Step 1** – From the OLGA 'Home' page, click on 'To provide public comments, click here'.

This action will display the screen in Step 2.



**Step 2** – Click the 'Show Lookup' button for a listing of Agencies that have submitted preliminary applications.

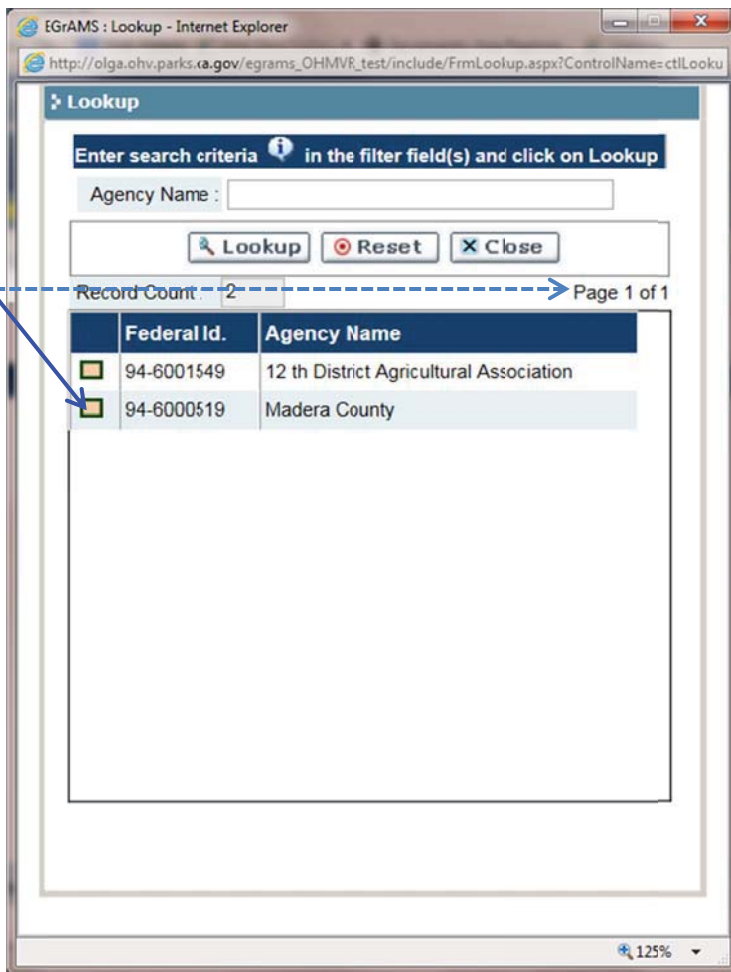
This action will display the screen in Step 3.



**Step 3** – Select the Agency you want to review by scrolling\* and clicking on the box next to the agency 'Federal ID' number.

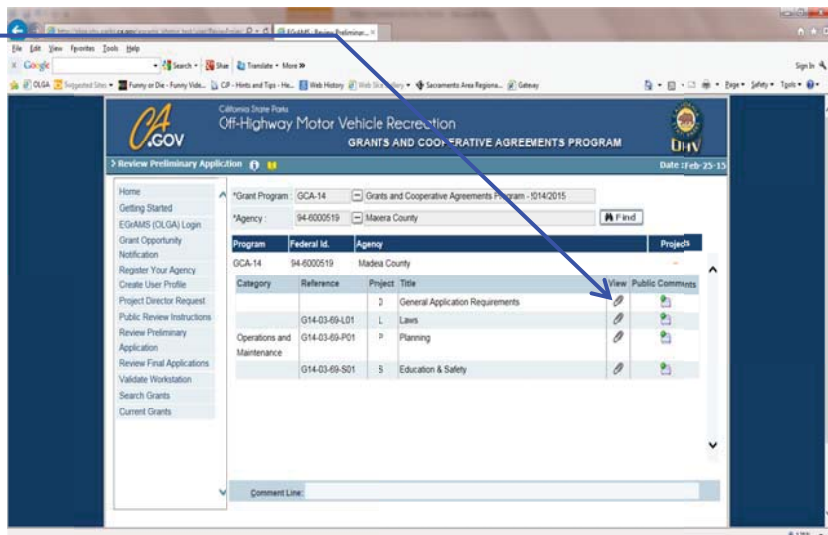
This action will display the screen in Step 4.

**Step 4** – Click the “paper clip” icon to view each section/project of the application.
