## **ROV OFFERS TIPS & REMINDERS ABOUT JUNE 5<sup>TH</sup> PRESIDENTIAL PRIMARY ELECTION**

### **Tuesday, May 29<sup>th</sup> Deadline**

The Registrar of Voters in Santa Clara County reminds voters that Tuesday, May 29<sup>th</sup> is the deadline to request a vote by mail ballot, by mail, for the June 5<sup>th</sup> Presidential Primary Election. Requests must be received by 5 p.m. on Tuesday, as postmarks are not accepted.

Vote by Mail applications are available on the back cover of the Sample Ballot & Voter Information Pamphlet or online at [www.sccvote.org](http://www.sccvote.org).

After Tuesday, ballots will only be available at the Registrar of Voters' (ROV) Office. The Office is located at 1555 Berger Drive, Building 2, San Jose.

### **Vote by Mail Ballots**

With more than 544,000 mail ballots issued to county voters and less than 66,000 or 12% received back as of today, there are thousands of ballots that have still not been returned. Voters holding on to their ballots are encouraged to complete them and return them as quickly as possible. There are a variety of easy and convenient ways to return them and ensure they are received in time.

### **Weekend Voting**

Voters can deliver ballots or vote in person at the ROV Office during Weekend Voting. The office will be open this Saturday, May 26<sup>th</sup> and Sunday, May 27<sup>th</sup> and Saturday, June 2<sup>nd</sup> and Sunday, June 3<sup>rd</sup>, from 9 a.m. to 3 p.m.

## **New! Drive-Thru Ballot Drop-Off Sites**

New Drive-Thru Ballot Drop-Off sites are being offered for the first time. There are five sites, one in each of the supervisorial districts, and they will be opened this Saturday, May 26<sup>th</sup> and Sunday, May 27<sup>th</sup> and Saturday, June 2<sup>nd</sup> and Sunday, June 3<sup>rd</sup> from 10 a.m. to 3 p.m. The sites will also be opened on Election Day, from 7 a.m. to 8 p.m.

## **Other Ballot Return Options (before Election Day)**

- City Clerk Offices in the county, during normal business hours
- Santa Clara County County Government Center at 70 W. Hedding Street, San Jose, during normal business hours
- Registrar of Voters' Office, during normal business hours, or the 24/7 drop-box located outside the office near the flag pole
- By mail, by May 30<sup>th</sup>, the last recommended date for mailing them

## **Signature on Mail Ballot Return Envelope**

Voters returning mail ballots must sign the ballot return envelopes themselves, so their ballots can be validated and counted.
