VOTING HAS STARTED FOR JUNE 23 SPECIAL RUN-OFF ELECTION IN SAN JOSE COUNCIL DISTRICT 4 *Over 28,000 Ballots Mailed to San Jose District 4 Voters*

SANTA CLARA COUNTY, CALIF. – Voting began today for the June 23, 2015 Special Run-off Election as the Santa Clara County Registrar of Voters mailed over 28,000 ballots to voters who have requested to Vote by Mail.

The ballots include a single contest to decide who will fill a vacancy on the San Jose City Council for District 4. Only registered voters who live in San Jose City Council District 4 are eligible to participate in the election. Voters who want to find out if they live within the District can look up their districts using the online tool at [Look Up Your Districts](#).

Vote by Mail voters account for approximately 69% of the 40,577 voters in San Jose City Council District 4.

Vote by mail voters who prefer to cast their ballots in person can also vote early at the Registrar of Voters' office. Voters who vote by mail can mail their ballots, drop off ballots at one of our ballot drop-off sites in their neighborhoods, visit one of the 26 polling places on Election Day, or even drive thru a weekend ballot drop-off site.

"It is important for voters to participate in these local special elections because voting ensures your voice is heard in your community," said Registrar of Voters Shannon Bushey.

Sample ballot pamphlets mailed the week of May 15 included an application to request a Vote by Mail ballot. Vote by Mail ballots may be requested by completing that application, applying on the website [Request a Vote by Mail Ballot](#), or calling us at 1-408-299-VOTE (8683) or toll free 1-866-430-VOTE (8683). The last day to request a ballot by mail is Tuesday, June 1.

Returning Vote by Mail Ballots

Vote by Mail ballots that are returned in-person must be received by 8 p.m. on Election Day, June 23. Vote by Mail ballots returned by mail must be postmarked on or before Election Day and must be received by Friday, June 26 (three days after the election). Voters are encouraged to mail their ballots as soon as possible. Voters must sign the return envelope themselves so the signature can be compared to the voter registration form to confirm the voter's identity.



Vote by Mail ballots can be returned in-person at the Registrar's office, any Santa Clara County polling place on Election Day, or at a designated ballot drop-off site. A complete list of ballot drop-off locations and hours is included in the Vote by Mail ballot packet and online at [June 23 Special Run-off Election Ballot Drop-Off Sites](#). Voters can track the status of their ballots online at www.sccvote.org or by using the free SCCVOTE mobile app.

Drive-Thru Ballot Drop-Off Site: Open Saturdays (June 13 & June 20, 2015) from 10 a.m. to 3 p.m. Vote by Mail (VBM) Voters will have the option of dropping off their ballots without getting out of their vehicles at a convenient Drive-Thru Ballot Drop-Off Site. The site will be located at the Hostetter LRT Station, Capitol Ave at Camino del Rey, San Jose, CA 95132.

Registering to Vote in the Election

The last day to register to vote in the election is Monday, June 8 and can be done online at [Register to Vote](#). Voters who want to check their registration status may do so on the website at [Check Your Registration Status](#).

A voter should complete a new registration form if he or she has moved, changed a name(s), or would like to change his or her political party preference. To register to vote in Santa Clara County, a voter must be a U.S. citizen, at least 18 years old on or before Election Day, a Santa Clara County resident, and not in prison or on parole for a felony.

Online registrations will be accepted as long as they are completed before midnight on June 8, paper registration forms that are postmarked prior to or on June 8 will also be accepted. Paper registration forms are available at post offices, public libraries, fire stations, city halls, and most local government offices.
