VOTER PAMPHLETS FOR CAMPBELL UNION HIGH SCHOOL DISTRICT MISSING CORRECT ARGUMENT AGAINST MEASURE AA

Corrected Information to be Mailed to Voters by Next Week

SANTA CLARA COUNTY, CALIF. --The Santa Clara County Registrar of Voters' Office announced today that the Sample Ballot and Voter Information Pamphlets distributed to voters in the Campbell Union High School District are missing the correct text of the Argument Against Measure AA. The Registrar of Voters' Office is acting swiftly to correct the issue, including mailing an errata letter to all registered voters in the affected district.

The argument against Measure AA that was printed in the pamphlets was filed by an individual voter of the district. However, a second argument was subsequently filed by a bonafide citizen's organization. State law requires that the organization's argument be given preference for publication; as a result of a clerical error, the wrong argument was printed instead.

"We are doing everything we can to make sure that voters are made aware of the issue and receive the corrected information," Registrar of Voters Shannon Bushey said. "The argument against Measure AA was filed correctly and on time. The inadvertent substitution of a different argument against Measure AA was not due to any fault of the argument's authors."

This issue affects approximately 110,850 information pamphlets sent to voters in the Campbell Union High School District. It does not affect any official ballots, which voters will use in order to vote at the polls or by mail. Official ballots do not include extrinsic materials such as arguments for or against measures.

In order to rectify the issue, the Registrar of Voters' Office will mail a corrected copy of the Arguments in Favor and Against, as well as both Rebuttals for Measure AA, to every registered voter in the Campbell Union High School District. Voters who opted to receive a paperless Sample Ballot and Voter Information Pamphlet will be sent an email notifying them of the corrected electronic copy.

The corrected arguments will be placed inside paper copies of the pamphlets that will be available at Early Voting Centers and at polling places on Election Day. An electronic correction will be added to the information pamphlets that are available online at www.sccvote.org and the SCCVOTE mobile app.
