This ballot stub shall be torn off by precinct board member and handed to the voter.

To vote for any measure, place the ballot card on a flat, hard surface. Press the tip of the punching instrument against the center of the circle which appears to the right of the word "YES" or to the right of the word "NO" and slowly lift the bottom of the ballot card until the circle completely detaches from the card.

All distinguishing marks or erasures are forbidden and make the ballot void. If you wrongly punch, tear or deface the ballot card or tear or deface the write-in ballot envelope, return it to the precinct board member and obtain another.

After voting insert the ballot card into the write-in ballot envelope and return it to the precinct board member.

MEASURE SUBMITTED TO VOICE OF VOTERS

CITY OF MORGAN HILL MEASURE

B Shall an initiative ordinance be enacted which amends the City General Plan, Map and Policy Statements to add a General Commercial Land Use category and commercial services standard and designates PUD-Commercial as the corresponding zoning; designates the northeast corner of the Morgan Hill Business Park (located at the southwest corner of Cochrane Road and South Valley Freeway) as General Commercial; (Parcel 1 and 2 only); amends the park Zoning and related development plan to change present "non-manufacturing business" designation to PUD commercial (Parcel 1 and 2 only); adopts permitted uses and development criteria for the PUD Commercial portion of the Park to include retail stores (excluding grocery supermarkets) and service uses with height, area, lot-depth, width, coverage, set-backs, parking, loading and sign requirements detailed in the ordinance; prohibits the City from requiring any discretionary permits for such uses or for construction of improvements for any permitted use in the non-manufacturing business designated areas of the Park; and may be repealed or amended only by a majority of the voters?
