General Qualifications: Must be 18 years of age or older, a US citizen, a legal resident within the District(s), a registered voter and not legally disqualified from holding an office.

❖ **Additional Qualification:** Current Board Members who were elected or appointed prior to 2001 and do not reside within the district are qualified so long as they continue to be a California voter and continue to own real property within the District. (See Public Resources Code section 5784.1)

* **Additional Qualification:** Must continue to reside within the electoral district during his or her term of office, except that no change in boundaries of an electoral district shall affect the term of office of any incumbent director.

† **Additional Qualification:** Must be either an owner of land within the District or be designated by an owner of land within the District as their representative.

‡ **Additional Qualification:** Must be a Veteran.

NOTICE IS FURTHER GIVEN that the Declaration of Candidacy for eligible candidates desiring to file for elective office may be obtained from the Santa Clara County Registrar of Voters' Office, 1555 Berger Drive, Building 2, San Jose, California, 95112. The Declaration of Candidacy will be available on Monday, July 16, 2018, and must be filed with the Registrar of Voters at the above noted address no later than 5:00 p.m., on Friday, August 10, 2018.

NOTICE IS FURTHER GIVEN that the Declaration of Candidacy for eligible candidates desiring to file for the Midpeninsula Regional Open Space District elective office may be obtained from the Midpeninsula Regional Open Space District, 330 Distel Circle, Los Altos, California, 94022. The Declaration of Candidacy will be available on Monday, July 16, 2018, and must be filed with the Midpeninsual Regional Office Space District at the above noted address no later than 5:00 p.m., on Friday, August 10, 2018.

NOTICE IS FURTHER GIVEN that, pursuant to Elections Code §15101(b), Vote by Mail ballots will be opened and processed for counting beginning October 23, 2018, at the Santa Clara County Registrar of Voters' Office, 1555 Berger Drive, Building 2, San Jose, California.
