TYPE OF INCIDENT: Vehicle Burglary Arrests

LOCATION: Cupertino, CA 95014

DETAILS:

Over the weekend, the Sheriff's Office arrested six individuals for a string of vehicle break-ins (14 cars total) throughout the City of Cupertino.

On Sunday 11/17/2019 at approximately 3:15 AM, deputies responded to a report of a vehicle burglary in-progress at an apartment complex on Pruneridge Avenue in Cupertino. The security company for the apartment complex saw three individuals breaking into vehicles through live feed surveillance cameras.

Upon arrival, deputies located three people hiding behind bushes and trees. All three people were detained. The suspects were identified as Salvador Adame Martinez (19) and two juvenile suspects. All three suspects matched the description on the surveillance videos and deputies located a stolen vehicle, stolen property and burglary tools nearby. Adame Martinez was arrested and booked into the Main Jail and the two juveniles were cited and released to their legal guardians.

Later that morning around 5:30 AM, deputies responded to another report of a vehicle burglary in-progress at a business parking lot near Stevens Creek Boulevard and Vista Drive in Cupertino.

Deputies stopped a vehicle leaving the area and detained three people. The suspects were identified as Eduardo Fierro (18), Angelique Lawler (18) and one juvenile suspect. All three suspects matched the description given by the reporting party and deputies located gloves, burglary tools, a camera and a flashlight nearby. All three suspects were arrested. Fierro and Lawler were booked into the Main Jail and the juvenile was booked into Santa Clara County Juvenile Hall.

Through both investigations, deputies located numerous stolen credit cards, identification cards, cell phones, checkbooks, electronics and other miscellaneous items in the suspects' possession. Investigators are still trying to determine if the two incidents were related or connected.
